



P&G Grab and Get DOLLARAMA Digital Gift Card Offer
Terms and Conditions

PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY. BY PARTICIPATING IN THIS PROGRAM, YOU AGREE TO BE BOUND BY THESE TERMS AND CONDITIONS AND ALL TERMS INCORPORATED BY REFERENCE. THE ISSUANCE OF A DOLLARAMA DIGITAL GIFT CARD IS SUBJECT TO MEETING ALL THE REQUIREMENTS OUTLINED BELOW.

Sponsorship and Administration

Procter & Gamble, Inc., 5160 Yonge Street, Toronto, ON, Canada M2N 6L9 (the “**Sponsor**”) is the sole sponsor of the P&G Grab and Get DOLLARAMA Digital Gift Card Program (the “**Program**”) and shall have full responsibility for the administration, management, verification, and fulfillment of the Program. The Sponsor shall be solely responsible for determining participant eligibility, resolving disputes, and managing the issuance and delivery of all DOLLARAMA Digital Gift Cards. After the delivery of the EGift Card, any issues related to the EGift Card is the responsibility of the gift card provider.

Gift Card Provider

All DOLLARAMA EGift Cards issued under the Program shall be managed by DOLLARAMA’s third-party gift card provider, which is solely responsible for the issuance, activation, tracking, balance inquiries, and technical management of the EGift cards.

Role and Limitation of DOLLARAMA

DOLLARAMA acts solely as a participating retailer facilitating the purchase of the Participating Products (as defined below) and is not a sponsor, administrator, promoter, or issuer of the Program or any eGift Card. All responsibilities, obligations, and liabilities relating to the issuance and delivery of EGift Cards lie with P&G. Any EGift Card activation, management, or use of any Dollarama Digital Gift Card lie exclusively with the gift card provider.-

Participants acknowledge and agree that Dollarama’s role is strictly limited to the sale of Participating Products, and Participants release, discharge, and hold harmless DOLLARAMA, its affiliates, officers, directors, employees, and agents from any and all claims, actions, damages, liabilities, or causes of action of any kind arising out of or related to: (a) participation in the Program; (b) submission of receipts or other Program requirements; (c) issuance, delivery, activation, or use of any EGift Card; or (d) any error, defect, or technical malfunction in the Program, website, or third-party systems.

Dollarama makes no representations or warranties regarding the Program or the EGift Cards, whether express or implied, including, without limitation, any warranties of merchantability or fitness for a particular purpose.

EGift Cards are non-transferable, non-reloadable, and will only be sent to the Participant whose valid email address appears on the registration associated with the Submission. Participants are responsible for any loss, damage, or misuse of their EGift Card.

Offer Timing

The Program begins on January 2, 2026 at 12:00 a.m. EST and ends on February 28, 2026 at 11:59 p.m. EST (the "**Purchase Period**").

Eligibility

The Program is open to legal residents of Canada who are age of majority in their province or territory in which they reside and have a valid email address ("**Participant**"). Groups, clubs, organizations, businesses, and commercial entities cannot participate. Void outside Canada and where prohibited. All provincial, territorial, municipal, and local laws and regulations apply.

How To Participate

During the Purchase Period, buy \$40 or more (after discounts, before taxes) of Participating Products (listed in Exhibit A, the "**Participating Products**") from any DOLLARAMA Canada location and submit a qualifying proof of purchase to be eligible for one (1) \$10 DOLLARAMA EGift Card. EGift Card to be used for future purchases. Proof of purchase includes a photo of the original in-store sales receipt ("**Receipt**"). Each Receipt must clearly show the retailer's name, date, time, location, Participating Product(s) purchased, and amount paid during the Purchase Period. Personal receipts only. Purchases may be made over multiple transactions during the Purchase Period.

To submit the Receipt, visit <https://www.pggooodeveryday.ca/dollarama> ("**Program Website**") and complete all required information to log in and/or register for the Program. After logging in or registering, follow the onscreen instructions to provide all requested information including uploading a clear photo or screenshot of your original itemized, store-identified, dated receipt(s) with the qualifying Participating Products made at DOLLARAMA during the Purchase Period (the "**Submission**"). Each eligible Receipt must be uploaded individually.

All Submissions must be uploaded by March 29, 2026 11:59 p.m. EST.

Limit 5 EGift Cards per person/email address, while supplies last.

Only online receipts through the Program Website will be accepted. Each receipt may only be used once. Receipts obtained through unauthorized means will be void, and unverifiable receipts will be rejected at Sponsor's discretion. Incomplete or illegible Submissions, or any Receipt that fails to meet these Terms and Conditions will not receive a EGift Card. Participants should keep a copy of their Submission documents. Proof of transmission (screenshots or captures etc.) does not constitute proof of delivery or receipt by the Program computers or Sponsor. All Submissions become the property of Sponsor and will not be returned.

If the Sponsor discovers that any person has attempted to use multiple names or email addresses or any automated, macro, script, robotic or other system(s) or program(s), and/or any other means not in keeping with the Sponsor's interpretation of the letter and spirit of these Terms and Conditions, to participate in or to disrupt this Program, they may be disqualified at the sole discretion of the Sponsor.

The Sponsor, DOLLARAMA, and their respective officers, directors, agents, representatives, successors, assigns, parent corporations, subsidiaries, affiliates and distributors (collectively, the "**Released Parties**") are not responsible for, and accept no liability whatsoever for any late, lost, misdirected, delayed, incomplete, or illegible Submissions.

Processing of Submissions

Eligible Participants will be emailed the EGift Card to the email address provided at time of registration. Allow up to 2 business days for verification and processing. If the Submission cannot be validated, the Sponsor may provide a reason at their discretion. It is the Participant's responsibility to check their email inbox, spam, and junk folders, for notifications from the Sponsor. Emails will be sent to the registered email address. Participants can visit their account dashboard on the Program Website for status submission(s). The Released Parties are not responsible for undelivered communications or the Gift Card once sent.

In case of a dispute, the EGift Card will be declared to be made by the authorized account holder of the e-mail address submitted at the time of registration. "Authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet Access provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. In the event of a dispute regarding the identity of the person submitting a registration form, the registration will be deemed to be submitted by the person in whose name the e-mail account is registered. Redemptions generated by scripts or bots are not eligible.

The Released Parties are not responsible for any computer related malfunction that prevents the recipient from accessing the registration form or receiving their EGift Card.

Verification

All Submissions and Participants are subject to verification at any time and for any reason. The Sponsor reserves the right, in its sole and absolute discretion, to request additional information when processing a EGift Card request. Failure to provide such information within the timeline specified by the Sponsor may result in disqualification.

EGift Cards

Acceptance of the DOLLARAMA EGift Card implies agreement to the terms and conditions of the EGift Card, which is subject to change at any time. The full terms of the EGift Card (the "**Gift Card Provider Terms**") are available at https://dollarama.cashstar.com/self_service/v2/about/terms_and_conditions. The EGift Card can be used at any DOLLARAMA location for future in-store purchases only and is not redeemable for cash or transferable. EGift cards are not reloadable or insured. EGift cards are subject to cancellation if issued in error, altered or obtained illegally, at the sole discretion of Sponsor.

By participating in the Program, Participant agrees to release, discharge, indemnify and hold harmless the Released Parties from any liability or damages which may arise out of participation in the Program or out of the acceptance, use, or misuse of any Gift Card.

ALL GIFT CARDS ARE AWARDED "AS IS" AND WITHOUT ANY WARRANTY OF ANY KIND, EXPRESS OR IMPLIED (INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE), AND ALL SUCH WARRANTIES ARE HEREBY DISCLAIMED.

General Conditions

The decisions of the Sponsor with respect to all aspects of this Program are final and binding without right of appeal. The Program is void where taxed, prohibited, or restricted by law. Applicable tax, if any, is the sole responsibility of the Participant.

The Released Parties will not be liable for: (i) any failure during the Program; (ii) lost or delayed requests; (iii) technical malfunctions; (iv) failure of any Submission to be received or recorded; (v) injury or damage related to participation; or (vi) any combination of these issues.

In the event of any discrepancy or conflict between the terms of this Program and the Gift Card Provider Terms, the Gift Card Provider Terms shall prevail.

Any legal action arising from these Terms shall be filed and adjudicated only in the federal or provincial courts located in Ontario (Judicial District of Toronto), and the Parties irrevocably consent to the exclusive jurisdiction of such courts.

By providing your information, you consent to the transfer of your data to jurisdictions outside your province and/or country of residence, which may have different data protection rules.
